Pursuant to Article 54. paragraph 1. item 11. and Article 95. paragraph 3. of the Law on Higher Education ("Official Gazette of the Republic of Srpska", No. 67/20) and Article 34. paragraph 1. item 12. of the Statute of the University of East Sarajevo, and on the Proposal of the Scientific-Teaching Council of the Faculty of Business Economics in Bijeljina from its Decision number: 253-02/21 dated 20 April 2021, the Senate of the University of East Sarajevo at its XV session held on 29 April 2021, enacted the following

DECISION on election into the title

Dr. Zoran Mastilo is hereby elected into the title of a **full professor** for the narrow scientific field of **Theoretical Economics**, at the Faculty of Business Economics in Bijeljina, University of East Sarajevo.

II

The candidate Dr. Zoran Mastilo is hereby elected into the title of full professor for an indefinite period of time.

III

The election referred to in item I of this Decision shall become effective upon enacting this Decision, and not before 18 June 2021.

Rationale

The Senate of the University, at the session held on 29 April 2021 in East Sarajevo, reviewed the Proposal of the Scientific-Teaching Council of the Faculty of Business Economics in Bijeljina number: 253-02/21 dated 20 April 2021, to elect the candidate, Dr. Zoran Mastilo into the title of full professor for the narrow scientific field of Theoretical Economics at the Faculty of Business Economics in Bijeljina. With respect to the given proposal, the following has been established:

The competition for the election of a teacher into the title of full professor or associate professor for the narrow scientific field of Theoretical Economics at the Faculty of Business Economics in Bijeljina was published on 30 December 2020 both in the daily newspaper "Glas Srpske" and on the webpage of the University of East Sarajevo.

By the decision of the Scientific-Teaching Council of the Faculty of Business Economics in Bijeljina number: 3-02121 dated 17 February 2021, the Committee for reviewing the competition material and writing the Report on the registered candidates for the election of teachers into the title of full professor or associate professor according to the given Competition was formed. The Committee entrusted with writing the Report on the registered candidates submitted a written Report to the Scientific-Teaching Council of the Faculty of Business Economics in Bijeljina and proposed that the candidate Dr. Zoran Mastilo be elected into the title of full professor for the narrow scientific field of Theoretical Economics. The subject Report was published on the website of the University on 26 March 2021.

Upon inspecting the Report by the Competition Committee, it was determined that a single candidate applied for the given Competition - Dr. Zoran Mastilo. Given that the competition was announced for election into the title of full professor or associate professor, the Committee, first assessed whether the candidate met the requirements for election into the title of full professor, set out in Article 77, paragraph 1, item đ) of the previous Law on Higher Education ("Official Gazette of the Republic of Srpska", number: 73/10, 104/11, 84/12, 108/13, 44/15, 90/16, 31/18, 26/19 and 40/20), which in accordance with the applicable Law on Higher Education, in terms of the minimum requirements for election into the title, is applied in the subject competition procedure.

Therefore, in Article 77, paragraph 1, item đ) of the Law on Higher Education, "Official Gazette of the Republic of Srpska", number: 73/10, 104/11, 84/12, 108/13, 44/15, 90/16, 31/18, 26/19 and 40/20) the minimum requirements for election into the scientific-teaching title of full professor in study programs at the university have been determined, i.e. it is specified that a candidate who is to be elected into the scientific-teaching title of full professor needs to fulfil the following requirements: 1) Spent minimum one election period as an associate professor, 2) has minimum eight scientific papers in the field which he/she is being elected in, published in scientific journals and peer-reviewed proceedings upon acquiring the title of associate professor, 3) has published no less than two books (science books, monographs or university textbooks) upon acquiring the title of associate professor, 4) has successfully implemented the mentorship of candidates for the degree of second or third cycle and 5) has established a successful international cooperation with other universities and relevant institutions in the field of higher education.

Upon inspecting the Report of the Committee, it was confirmed that the Competition Committee established that Dr. Zoran Mastilo meets the legal requirements for election into the title of full professor for the narrow scientific field of Theoretical Economics. Furthermore, it was established that the Competition Committee conducted an interview with the candidate Dr. Zoran Mastilo. In its Final Opinion, the Committee proposed that the candidate Dr. Zoran Mastilo be elected as a full professor, for the narrow scientific field of Theoretical Economics at the Faculty of Business Economics in Bijeljina. Upon reviewing the Report of the Competition Committee, the Scientific-Teaching Council of the Faculty of Business Economics Bijeljina enacted the Decision number: 253- 02/21 dated 20 April 2021, confirming the proposal to elect the candidate Dr. Zoran Mastilo for the narrow scientific field of Theoretical Economics, based on the Competition for the appointment of teachers as full professors, and submitted it together with the entire competition material to the University Senate for further procedure.

The mentioned Proposal of the Scientific-Teaching Council of the Faculty of Business Economics in Bijeljina, the Report of the Competition Committee and the entire competition documents were reviewed by the Social Sciences Council at its session held on 29 April 2021 and on that occasion delivered an opinion that the proposed candidate Dr. Zoran Mastilo be elected as full professor for the narrow scientific field of Theoretical Economics.

Upon reviewing the Proposal of the Scientific-Teaching Council of the Faculty of Business Economics in Bijeljina number: 253-02/21 from 20 April 2021 and the Report of the Committee, and in the light of the opinion of the Social Sciences Council, and given that the proposed candidate meets the legal requirements for election into the academic title under the competition mentioned above, the University Senate decided as in the enacting clause of this Decision.
