The organizer and co-organizers have the obligation to jointly advertise, promote and invite as many participants as possible, domestic and foreign origin, with the obligatory posting of a link to the invitation to the scientific conference on their websites.

The organizer has the obligation to provide the conference room and all the necessary technical and linguistic support.

Accommodation costs are borne by each co-organizer separately.

The costs of publishing papers are paid by each author separately (the cost of the registration fee is included as part of the advance payment for publishing the papers). For all authors brought by the organizer and co-organizer, the income from participation belongs to the organizer.

The co-organizers is obliged to provide at least 5 papers from different authors, regardless of which country they come from, and the papers are directed according to the name of the topic of the scientific conference.

Each co-organizer with organizer will conclude an individual (special) annex to this agreement, which will regulate the issue of the budget. Therefore, the goal is to form a common budget that will finance the conference.

The agreement enters into force on the day of signing.
