

GENERAL PROTOCOL OF ACTION

BETWEEN

OIKOS INSTITUTE – RESEARCH CENTRE (BIJELJINA, BOSNIA AND HERZEGOVINA)

AND

WSEI UNIVERSITY IN LUBLIN (LUBELSKA AKADEMIA WSEI, LUBLIN, POLAND)

From one part, Oikos Institute – Research Centre represented by the director prof dr. Zoran Mastilo

and from the other party, Associate Professor TOMASZ WOŁOWIEC, PhD., DsC., Vice-Rector of WSEI University for Science and International Relations, acting in the name of the WSEI University in Lublin, Poland

Both parties recognize each other's legal capacity to sign this agreement and

DECLARE THAT:

The Oikos Institute – Research Centre and WSEI University in Lublin manifest their intention to reach an agreement to foster academic cooperation according to the following terms and conditions:

ARTICLE 1. The Oikos Institute – Research Centre and WSEI University in Lublin agree to promote joint teaching, research, and other academic activities, especially student and staff mobility and any other program of mutual benefit to both universities.

Matters pertaining to the implementation of this protocol shall be approved in writing through a specific agreement signed by both parties before any such programs or activities can be undertaken.

ARTICLE 2. Resources for the implementation of specific programs may derive from either party or from external funds. However, this General Protocol of Action does not

oblige either party to expend any resources in connection with the objectives herein specified unless explicitly stated otherwise in the corresponding specific agreement.

ARTICLE 3. In all cases in which, as a consequence of and in application of the agreements laid down herein, one university considers it necessary to use the logo of the other university, it must previously ask this University for permission through the agreement's coordinator, specifying the corresponding application (graphic, electronic or any other format) and the type of use for which it is being requested.

The authorization will in all cases be issued in writing and will specify the use or uses for which it is granted as well as the period of validity.

ARTICLE 4. This Protocol will be effective for a period of four (4) years from the date of its signing.

After this period, this Protocol may be extended for a period of up to four (4) additional years or may be terminated or modified at any time prior to its expiration date, upon written agreement signed by the authorized representatives of both parties.

ARTICLE 5. The termination of this Protocol can have the initiative of any of the parties with a written notice period of not less than six months. In any case, the parties undertake to facilitate the consecution of the programs and activities already initiated. This Protocol does not imply any financial duty upon the University of Alcalá neither WSEI University in Lublin

ARTICLE 6. Each institution appoints a coordinator for the implementation of this Protocol, who will be responsible for defining and organizing the programs to be undertaken and for interaction between the two institutions.

The **WSEI University in Lublin** appoints as the coordinator for liaising between the two institutions:
